

RESOLUTION NO. 3270

RESOLUTION AUTHORIZING THE MAYOR TO ISSUE A PURCHASE ORDER  
TO SWS EQUIPMENT, LLC, FOR A STREET SWEEPER

WHEREAS, the City was awarded funding through the Federal Highway Administration's (FHWA's) Congestion Mitigation & Air Quality (CMAQ) Grant Program Funding for the purchase of a new PM10 certified street sweeper; and

WHEREAS, the City solicited competitive sealed bids from interested contractors for the procurement of this equipment, comparatively evaluated the received bids, and determined the lowest responsible bidder to be SWS Equipment, LLC, of Spokane, Washington; and

WHEREAS, the City desires to award this project to SWS Equipment, and to issue a purchase order for the overall total cost of \$418,637.96; and


WHEREAS, the written "Bid Proposal" measuring fourteen total pages (which is part of a larger total package of bidding documents which include the specifications, bid material, and other items) has been prepared, and the terms of the proposed Bid Proposal are acceptable to City staff; and

WHEREAS, the City Council finds that good cause exists;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SELAH, WASHINGTON, as follows: (1) that the Mayor be and is authorized to sign, and Public Works Director Rocky D. Wallace be and is authorized to fill-in the appropriate data on any blank lines on, the fourteen-page Bid Proposal with SWS Equipment, LLC, in the form appended hereto in order to issue a purchase order for the street sweeper; (2) if an award letter and/or any other documentation proves necessary to effectuate awarding and/or receiving the street sweeper, the Mayor and/or Mr. Wallace be and are likewise authorized to sign and/or prepare such; and (3) if it becomes possible for the City to obtain the street sweeper for a lessor amount than currently contemplated, the Mayor and/or Mr. Wallace be and are authorized to enter into and/or sign any necessary agreements or documents without further approval by the City Council.


