

TYPES OF BONDS

LIMITED TAX GENERAL OBLIGATION BOND (Non-voted) —

Secured by the General Fund/Current Expense Fund. (A Limited Tax General Obligation Bond is also known as "non-voted debt". Any type of debt that is secured by the General Fund, is counted against the municipality's "non-voted" Debt Capacity.)

UNLIMITED TAX GENERAL OBLIGATION BOND (Voted) —

Secured by the full faith, credit and taxing power of the municipality with a special excess voter-approved bond levy.

REVENUE BOND –

> Revenue bonds are payable from a specific source of revenue from the System operations (i.e., Water & Sewer System charges).

LOCAL IMPROVEMENT DISTRICT ("LID") BOND -

Secured by the property assessments in the LID boundary that are receiving the benefits. The assessments cannot be greater than the improvement






BOND MARKET INTEREST RATE TREND





A. Call to Order: Mayor Raymond called the meeting to order at 5:30 pm.

B. Roll Call

C. Councilmember Absence: Councilmember Iverson, Councilmember Carlson

Councilmember Bell moved to excuse Councilmember Carlson and Councilmember Iverson from the meeting. Councilmember Peterson seconded. By voice vote, motion passes unanimously.

- E. Invocation: Councilmember Wickenhagen gave prayer
- F. Agenda Changes

Mayor Raymond stated that Ordinances would be addressed first, then Resolutions. City Clerk/Treasurer Novobielski suggested that because Ordinance O-1 was dependent on the passing on Resolution N-1, perhaps the Council should wait to take action on O-1 until after the Resolution N-1 is passed. Mayor Raymond agreed. Stated O-2 would be addressed first before Resolutions.

- G. Public Appearances/Introductions/Presentations
 - 1. Katrina Henkle from the Selah Downtown Association gave report and updated council on events happening around town.
 - 2. Mike Johnson, CEO of Yakima Union Gospel Mission gave presentation and discussed the issues surrounding legalizing marijuana in the US (see attached documents provided to Council for Mr. Johnson's presentation). Mr. Johnson discussed the impacts of marijuana use and the impacts it has on communities, lower-income neighborhoods, and the surrounding communities when marijuana

business are allowed in cities. Referenced the increase in property crime and petty theft as well as traffic safety problems.

- 3. Dena Johnson, from Dena Johnson Counseling and Attachment & Trauma Informed Care for Adults & Families, Specializing in Adopted Children, gave presentation and provided information on the impacts of marijuana use in pregnant mothers, pre-natal exposure and the resulting effects on infants and children. Ms. Johnson stated that in her business and working with DSHS, they have seen a significant rise in children born exposed and addicted to marijuana. This results in children with increased rate of learning disabilities, decrease in executive function skills, decreased verbal skills, decreased memory function. increased hyperactivity, and increased socially impulsive behavior.

Councilmember Peterson requested that what he said was that Ms. Huerta was working with Mr. Chavez in the development of the United Farm Workers of America.

Councilmember Bell moved to approve the consent agenda as amended. Councilmember Wickenhagen seconded. By voice vote, motion passes.

Introduced by Mayor Raymond, and presented by Attorney Case. Mr. Case gave brief information regarding the ordinance, then introduced Mr. Lee Marchisio, from Foster Garvey. Mr. Marchisio briefly discussed the bond and terms, and referenced section 8 of the ordinance. Mr. Marchisio also explained that a yes vote today would pass the ordinance and authorize the bond to go on the August 7 ballot.

Councilmember Bell asked a question regarding section 6. Requested clarification that the funds are to be used for only the Law and Justice Center, but that if the project comes in under budget, the council can use the funds elsewhere. Mr. Marchisio confirmed, yes, and referenced a similar project where a fire station was being built, and came in under budget, so the City used the bond funds for another fire station project. Mr. Marchisio also stated that the Council does not have to issue all of the bonds available.

Councilmember Peterson moved to approve ordinance as written. Councilmember Marquis seconded to approve the Ordinance of the City of Selah, Washington, Providing for the Submission to the Voters of the City at a Special Election to be Held on November 8, 2022, in Conjunction with the State Election to be Held on the Same Date, of a Proposition Authorizing the City to Issue General Obligation Bonds in the Aggregate Principal Amount of no more than \$12,700,000 for the Purpose of Paying Costs of Constructing a Law and Justice Center, the Principal of and Interest Payments on such Bonds to be Payable from Annual Excess Property Tax Levies; Designating the City Administrator and Bond Counsel to Receive Notice of Ballot Title from the Yakima County Auditor; and Providing for Related Matters.

Roll was called. Councilmember Wickenhagen – yes; Councilmember Iverson – absent; Councilmember Marquis – yes; Councilmember Peterson – yes; Councilmember Bell – yes; Councilmember Costello – yes; Councilmember Carlson – absent. By voice vote, Resolution passes unanimously.

N-2 Resolution Authorizing the Mayor to Sign, on Behalf of the City, Change Order No.3 with Belsaas & Smith Construction, Inc., for Work on Certain Components of the Selah Wastewater Collections Improvements Project.

Introduced by Mayor Raymond, and presented by Public Works Director, Rocky Wallace. Explained that Tree Top gave a specific time for project to be completed, but then stated they are getting busy sooner than expected and needed to adjust the timeline. Mr. Wallace explained that the City will pay for changes with Belsaas and Smith, and then request reimbursement from Tree Top.

Councilmember Peterson asked about the current agreement. Mr. Wallace stated that it is currently a verbal agreement, but passing this resolution would make it certain.

Councilmember Peterson moved, and Councilmember Costelo seconded, to approve the Resolution Authorizing the Mayor to Sign, on Behalf of the City, Change Order No.3 with Belsaas & Smith Construction, Inc., for Work on Certain Components of the Selah Wastewater Collections Improvements Project.

Councilmember Wickenhagen asked for an opinion on this issue from City Attorney Rob Case. Mr. Case stated that not having something in writing is sub-optimal, but in this case, it seems it will all work out.

Councilmember Bell moved, and Councilmember Wickenhagen seconded, to approve the Resolution Authorizing the Mayor to Sign, on Behalf of the City, an Amendment to the Owner-Engineer Agreement (Amendment No. 01) with HLA Engineering and Land Surveying, Inc., for Work on Certain Components of the Selah Wastewater Collections Improvements Project.

Councilmember Marquis asked if the change order was in addition to or directly related to the man hole. Mr. Wallace said it was in addition to.

Councilmember Peterson asked for clarification on the change. Mr. Wallace said it was an amendment to the engineering services with HLA, not the construction with Belsaas and Smith. Mr. Wallace stated, yes, everyone missed this in the original bid. City Administrator, Henne said, due to the size of the project, an amendment and secondary review from HLA would have probably been done anyway.

Councilmember Bell asked what can be done in the future to prevent this from happening again. Mr. Wallace said, though they always try to get it perfect, mistake are inevitable, especially with a project of this size. City Planner Peters added that since the plans used for this project were so old, there were many unknowns.

- Ron Anderson, Civic Center Coordinator gave update on the recent events in the City and current happenings at the civic center.

SPRSA has also agreed to heat the pool until October. SPRSA also approved the rental of pool to the Dolphin Swim Team in 2023 to host the Mid-Valley Championships. SPRSA also decided not to run a levy in 2022.

- 3. City Attorney Report Gave update on Safe Litigation. Stated that the only item left is for all sides to sign. Mr. Case also plans to have the Mayor's signature be the final signature. Mr. Case provided information regarding the current sign code, section 10.38 of SMC, adopted in 2021, specifically section 10.38.080 which governs where signs can be placed in public rights of way. Reminded the public that the signs don't

have to be political signs, and reminded the public that all citizens of the City can post signs as long as they adhere to the code.

- Mayor Raymond asked about signs on telephone poles. Mr. Case stated that his general understanding is that Public Works and Code Enforcement has not been removing signs from telephone poles or citing citizens for leaving them up.
- Councilmember Peterson asked about state law regarding posting on telephone or utility poles. Mr. Case said, perhaps, but he has not seen anything so far.
- Mr. Henne reminded Council that the telephone poles are private property.
- Mr. Case stated that the old sign code did reference signs on poles, but generally they were just removed, and that citations were not usually issued; but that the new code generally states no action would be taken.



Section 1: Introduction

The Transportation Development Plan 2023 - 2028 provides updated information and forecasts to the Washington State Department of Transportation on Selah Transit's current components and accomplishments as well as proposed action strategies for 2023 - 2028.

This document is also used to notify the public about projects, which have been completed, are in process, or are planned for the future. Following a public hearing, the Selah City Council will approve this plan before this document goes into effect.

Section 2: History


Selah was officially incorporated on April 3, 1919. Selah has a strong major form of government. Selah's base economic activity primarily consists of fruit warehousing/processing facilities due to the proximity of fruit orchards in the nearby Wenas Valley and access to regional railroad and roadway systems for shipment to markets.

Selah's Transit services are funded by a voter-approved 0.3% sales tax in 2007. In 2009 the City of Selah began public transit service through a contract with Yakima Transit providing fixed routes and Para-Transit services. In May 2018 the City of Selah ended its contract with Yakima Transit and contracted with Medstar Transportation to provide both fixed route and paratransit services.

Section 3: Location

Selah covers 4.37 square miles (2796.5 acres), with a population of 8,180. It is located in Yakima County, which spans 4,296.1 square miles – the second-largest land area and seventh-largest population area in Washington State, with a population of 250,873.





Section 4: Organization

Selah Transit is a municipal transit system as authorized in RCW 35.58.2795.

The Selah City Council governs Selah Transit.


Selah Transit is a municipal transit system as authorized in RCW 35.58.2795 and is located in Yakima County. The City of Selah does not have any transit-specific employees dedicated to Selah's Transit operations. Selah's transit-related staff consists of administrative personnel that support the City as a whole, including positions from City Hall and Public Works. The Selah City Administrator oversees Transit contracts transit services for both fixed route and paratransit ADA services with Medstar Transportation.

As of 08/01/2021, Selah Transit's contractor employed:

- 1 full-time employee in the operations division
- 5 full-time equivalents in the Dial-A-Ride Paratransit division
- .5 full time equivalent in the maintenance division
- .5 full time equivalent in the administration division
- .5 full-time equivalent employed by The City of Selah transit division
- 7.5 Total Transit employees

Section 5: Physical Plant

The contractor's facility is located at 1904 Fruitvale Blvd., Yakima, WA 98902. Their contracted services provider Medstar Transportation owns the building



Section 6: Service Characteristics

Selah Transit operates 2 fixed-route buses. The Selah Route operates within the City of Selah Monday through Friday from 6:45 a.m. to 5:50 p.m. and Saturday from 10:30 a.m. to 5:07 p.m. The Selah/Yakima Route operates Monday through Friday from 6:30 a.m. to 6:33 p.m. and Saturdays from 10:30 a.m. to 4:31 p.m. Each route has a midday break in the schedule. There are no fixed route services on Sundays or federal holidays.

Dial-A-Ride Paratransit service operates the same service hours as the fixed-route service.

For further details on our local fixed route services or Dial A Ride rules and applications, please visit us at https://selahwa.gov or www.gomedstar.com or see the back section of the Yakima Transit Bus book.

The vehicles are owned and operated by Medstar Transportation and include a combination of ADA accessible

passenger cutaway chassis vehicles and Grand Caravan minivans. Because all vehicles used in the provision of transit services are purchased and owned by the contractor and not the City of Selah, there is no listing for capital expenditures for buses in this plan. When vehicles are listed as additions to or replacements of vehicles used for transit purposes, it is for fleet description only and no Capital funds are used at this time but could be considered in the future.

Section 7: Service Connections

Selah Transit connects with Yakima Transit routes 3 and 4 at 40th Ave and N 16th Ave. It also connects with route 7 at 40th Ave and Route 8 at N 16th Ave. Selah Transit connects with Union Gap Transit at the Sears passenger shelter on Valley Mall Blvd and Main St as well as connections with Pahto Public M-F at 10:45 a.m., 2:30 p.m. and again at 5:10 p.m. These connector routes meet up with the Ellensburg Commuter, CWA Airporter Shuttle for trips to Seattle, and the Community Connector for trips throughout Yakima County as well as connections to Ben Franklin Transit.

Selah Transit offers Dial A Ride services within the City of Selah and to and from the city limits of Yakima and Union Gap.

Section 8: Service Development & Improvements

- The contractor will continue to work closely with the City of Selah to promote Selah Transit, emphasizing increasing fixed-route ridership. Use surveys to improve routes.
- The contractor will work with the City of Selah to promote local businesses.
- Use innovative software to streamline operations and efficiencies.
- Mobility management.
- Micro Transit to transport residents to fixed-route connections.

Section 9: Selah Transit Development Plan & WSDOT - Operating & Investment Guidelines:

Preservation: Continue to meet all the requirements of the ADA as it applies to fixed-route and paratransit services. Maintain or increase levels of service, and try to add more alternative fuel or hybrid vehicles.

Safety: The continued modernization of the vehicle fleets including fleet software will improve system safety by enlisting the latest safety-related technology, securement, and maintenance systems. The installation of new bus shelters will also improve system safety by providing a waiting area that is both well-lit and away from traffic.

Mobility: All Selah Transit vehicles are ADA-accessible vehicles equipped with Q'Straint securement systems. This allows total accessibility for those who can access the fixed route systems as well as for those residents who use paratransit services.

Environment: By the year 2028, we hope to have converted all transit vehicles to hybrid or alternative fuel technology to enhance a healthy community, promote energy conservation and protect our environment.

Stewardship: It is the intent of Selah Transit, to work towards greater efficiency and to improve the quality of our on-demand transportation services with efficient routes and studies for future investment in micro-transit services for local and outlying businesses. This could include an on-demand rider App that allows riders to easily view the ETA of each vehicle in real-time.

Section 10: Plan Assumptions

Population – According to the 2022 census report, the Selah Transit service area population is 8,180.

- 1. Sales Tax: We are expecting Sales Tax to increase at a rate of 2% through 2028.
- 2. **Inflation Factor:** Medstar Transportations wage and salary costs will increase by 6.00% per year throughout the plan due to Washington State Minimum Law potential changes. All other costs will increase at an estimated 4.00% per year throughout the plan.
- 3. **Fixed Route Bus Service:** In 2022 Selah Transit will provide approximately 5,581 hours of revenue service. Ridership will be consistent through 2028.

Depicts the month ridership totals since the implementation of services by Medstar Transportation through 2022.




Figure 2: Selah Transit Route Daily Average by Month

The graph depicts boarding/exits per day by an average by day through 2022.





Figure 4: Dial-A-Ride ADA Paratransit Service







AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SELAH, WASHINGTON, IDENTIFYING POLICIES AND PRIORITIES FOR USAGE OF AMERICAN RESCUE PLAN ACT (ARPA) FUNDS, APPROVING A CERTAIN AMOUNT THEREOF FOR INITIAL EXPENDITURES FITTING WITHIN SPECIFIC EXPENDITURE CATEGORIES (ECS) IDENTIFIED BY THE DEPARTMENT OF TREASURY, AND ESTABLISHING A CITY OF SELAH ARPA PROGRAM.

FINDINGS

WHEREAS, COVID-19 is a contagious and potentially deadly virus that has been declared a pandemic event by the World Health Organization; and

WHEREAS, actions taken to mitigate the spread of COVID-19 have resulted in social and economic disruption throughout the City of Selah; and

WHEREAS, the COVID-19 Delta Variant has resulted in some of the highest hospitalization rates throughout the pandemic, with no end of its effects yet seen; and

WHEREAS, on March 11, 2021, the federal government enacted the American Rescue Plan Act (ARPA) that is expected to provide \$2,259,675 of funds to the City of Selah, with the City of Selah being a nonentitlement unit of local government (NEU) as defined in section 603(g)(5) of the Social Security Act and as added by section 9901 of the American Rescue Plan Act of 2021, because the City of Selah is a local government that typically serves a population of less than 50,000; and

WHEREAS, the United States Department of the Treasury will allocate funding to the City of Selah in two substantially equal tranches, with the first tranche of \$1,129,838 having already been received by the City of Selah in 2021, and the second tranche of \$1,129,837 having been transmitted to the City of Selah on July 5, 2022; and

WHEREAS, ARPA authorizes expenditures of funds to respond to the public health emergency and its negative economic impacts, and also to make necessary investments in water, sewer or broadband infrastructure; and

WHEREAS, due to the duration of the pandemic and the ongoing negative impact on public health and the economy upon which the public depend, Selah residents and businesses continue to experience physical stress and economic stress; and

WHEREAS, the City of Selah has a need to make improvements to its water, sewer and broadband infrastructure; and

WHEREAS, on July 26, 2022, the City Council of the City of Selah held a duly noticed public hearing regarding the potential usage of ARPA funds, so that members of the public could provide input; and

WHEREAS, the City Council of the City of Selah completed its consideration of public input and its deliberations regarding the potential usage of ARPA funds on July 26, 2022;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SELAH, WASHINGTON, DO ORDAIN AS FOLLOWS:

- Section 1. Adoption of City Council Findings. The findings of the City Council, as recited in the preceding recitals (*i.e.*, "WHEREAS" paragraphs above), are incorporated within and adopted as part of this Ordinance.
- Section 2. Adoption of Policies and Priorities for Use of American Rescue Plan Act (ARPA) Funds. The "Policies and Priorities for Use of American Rescue Plan Act (ARPA) Funds" set forth on Exhibit A to this Ordinance are approved and are incorporated within and adopted as part of this Ordinance.
- Section 3. Adoption of ARPA Expenditure Categories. The "Expenditure Categories" set forth on Exhibit B to this Ordinance are approved and are incorporated within and adopted as part of this Ordinance.
- <u>Section 4.</u> <u>Initial Expenditures Approved.</u> The "Initial ARPA Expenditures" recited within Exhibit C to this Ordinance are approved and are incorporated within and adopted as part of this Ordinance.
- Section 5. Establishment of ARPA Program. The City Administrator is hereby authorized to establish and implement a City of Selah ARPA Program to provide the opportunity for individuals, organizations and governmental units to apply for ARPA funds as sub-recipients, provided that their applications and proposed uses of funds comply with ARPA and the Department of the Treasury Guidance and further provided that expenditures are approved consistent with the City of Selah ARPA Program processes. The City of Selah ARPA Program will include the needed resources to track and report on the use of ARPA funds as required by the Department of the Treasury.
- Section 6. Emergency. This Ordinance is necessary for the immediate preservation of the public peace, health, safety or support of the City of Selah government and its existing institutions, to provide relief to citizens and businesses during the COVID-19 pandemic.
- Section 7. Severability. If any portion of this Ordinance or its application to any person or circumstances is held invalid, the remainder of the Ordinance or the application of the provision to other persons or circumstances shall not be affected.
- <u>Section 8.</u> <u>Effective Date.</u> This Ordinance takes effect from and after its passage and five days following its publication as required by law.

Policies in addition to those adopted as part of this Ordinance per its Findings:

- 1. Provide ARPA and other COVID-19 related resource of stress and mental services to Selah residents and businesses.
- 2. Provide support to people living in Selah, and its organizations operation in Selah's "hardest hit communities" as defined in Department of the Treasury guidance.
- 3. Improve infrastructure in Selah to mitigate historical inadequate infrastructure and health issues in "older and underserved parts of the community" as defined by the Department of the Treasury as well as to spur economic recovery.
- 4. Improve Selah's delivery of municipal services to its residents and businesses in light of COVID (i.e. facility and operations improvements)

Priorities for Use (not listed in order of importance):

- 1. Responding to Public Health Emergency
 - a. Support COVID-19 testing and vaccination efforts at Selah Civic Center.

2. Assistance to nonprofits:

- a. Provide ARPA and COVID-19 resource services to Selah residents, including in partnership with Selah-Naches Food Bank to aid in helping with their functions & goals.
- **b.** Provide financial assistance to non-profits and human services organizations, i.e. Selah Food Bank operating in Selah.

3. Provision of government services:

- Support facility improvements, infrastructure improvements, and other ARPAeligible program expenditures, including in partnership with public partners, Selah Water Distribution & Sewer Collection Systems and Sewerage Treatment.
