RESOLUTION NO. 2808

RESOLUTION AUTHORIZING THE MAYOR  
TO SIGN A "POLICE CHIEF EMPLOYMENT  
CONTRACT" WITH DANIEL V. CHRISTMAN

WHEREAS, the City's position of Police Chief is currently vacant;

WHEREAS, the City solicited applications from potentially-interested applicants, and in response to such solicitation the City received application materials from multiple applicants;

WHEREAS, a five-member panel consisting of City personnel and also members of the public was appointed to conduct interviews of applicants and to make a recommendation to the Mayor as to which applicant should be selected for potential hire, such panel conducted such interviews and thereafter unanimously recommended to the Mayor that Daniel V. Christman be selected for potential hire, and the Mayor considered such recommendation and ultimately agreed with the panel's selection of Mr. Christman;

WHEREAS, the position was conditionally offered to Mr. Christman and Mr. Christman conditionally accepted the position, subject to agreement upon specific terms of employment to be specified within a written employment contract and also subject to other applicable pre-hire processes such as a standard background investigation and a standard psychological evaluation;

WHEREAS, the background investigation has been completed and revealed no obstacles to hiring Mr. Christman, and the psychological evaluation will occur after the City Council might authorize the Mayor to sign and enter into a contract with Mr. Christman but prior to such contract taking force and effect; and

WHEREAS, the parties have reached an informal agreement on the provisions of a written "Police Chief Employment Contract", and a copy of such proposed contract was presented on or about September 18, 2020, to each member of the City Council for review and preparation for a vote by the City Council as to whether to authorize the Mayor to sign and enter into such contract on behalf of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SELAH, WASHINGTON, that the Mayor be authorized to sign and enter into the "Police Chief Employment Contract" in the form previously presented to the City Council, and further that City staff be authorized to make non-substantive corrections or additions to this Resolution immediately prior to its execution by the Mayor to correct any typographical errors that might exist.
